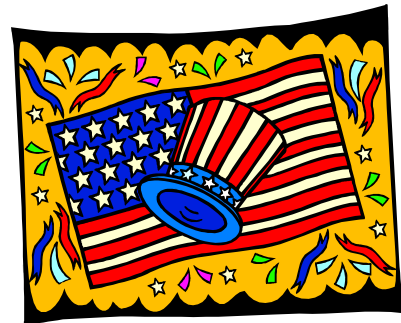
“We the People...”  July 17-19, 2009  North Little Rock, AR
