
I hope all of you make plans to come to the Annual Meeting. It will be a lot of fun, as always. I look forward to serving you as President of our state association.

#### **NALS Code of Ethics & Professional Responsibility**

Members of NALS are bound by the objectives of this association and the standards of conduct required of the legal profession. Every member shall:

- Encourage respect for the law and administration of justice
- Observe rules governing privileged communications and confidential information
- Promote and exemplify high standards of loyalty, cooperation, and courtesy
- Perform all duties of the profession with integrity and competence
- Pursue a high order of professional attainment



- **Canon 1.** Members of this association shall maintain a high degree of competency and integrity through continuing education to better assist the legal profession in fulfilling its duty to provide quality legal services to the public.
- **Canon 2.** Members of this association shall maintain a high standard of ethical conduct and shall contribute to the integrity of the association and the legal profession.
- Canon 3. Members of this association shall avoid a conflict of interest pertaining to a client matter.
- **Canon 4.** Members of this association shall preserve and protect the confidences and privileged communications of a client.
- **Canon 5.** Members of this association shall exercise care in using independent professional judgment and in determining the extent to which a client may be assisted without the presence of a lawyer and shall not act in matters involving professional legal judgment.
- Canon 6. Members of this association shall not solicit legal business on behalf of a lawyer.
- **Canon 7.** Members of this association, unless permitted by law, shall not perform paralegal functions except under the direct supervision of a lawyer and shall not advertise or contract with members of the general public for the performance of paralegal functions.
- **Canon 8.** Members of this association, unless permitted by law, shall not perform any of the duties restricted to lawyers or do things which lawyers themselves may not do and shall assist in preventing the unauthorized practice of law.
- **Canon 9.** Members of this association not licensed to practice law shall not engage in the practice of law as defined by statutes or court decisions.
- **Canon 10.** Members of this association shall do all other things incidental, necessary or expedient to enhance professional responsibility and participation in the administration of justice and public service in cooperation with the legal profession.

Metro LPA has had an exciting year with professional speakers at each month's luncheon. We've learned about various issues in family, wills and estates, and criminal law; heard about problems and possible solutions with the MS Vulnerable Persons Act; and were honored to be joined by Hinds County Sheriff Victor Mason. Our Luncheon Committee Chairman, Felicia Turner, has done an excellent job over the last few years in providing educational and interesting speakers for our meetings. We greatly appreciate her efforts in ensuring our luncheons are informa-

We were proud to present Roslynn Solis-Champion with the 2017 Award of Excellence for her hard work and dedication to the Metro LPA.

Corinne Crowder was the 2017 Scholarship recipient for Metro LPA. She is a paralegal major at Holmes Community College and was very appreciative of the local award and the chance at the statewide award.



#### Certifications Committee Report—Darleen Dozier

In September 2016, directors of the MS Community Colleges offering Paralegal Technology degrees met for a curriculum revision. In an effort to give students something valuable to leave college with, in addition to a degree, they voted for a mandatory exit exam consisting of a national certification. The two exams chosen were the ALP from NALS and the CP from NALA. Directors have an option of which exam to require students to take, however, directors agreed that NALS' ALP exam would probably be the choice they would make.

Itawamba Community College began giving the ALP last year voluntarily. Holmes Community College will give the ALP beginning in April. All other community colleges will have mandatory testing beginning with the Fall 2018 semester. NALS is working with each college for special testing dates that will enable students to take the exam in the final month before graduating.

Holmes Community College offers a last-semester class that prepares students to take the ALP. Other colleges discussed implementing the same type of preparation. Not only will this enlarge our memberships, but it will bring more awareness in the area of NALS and the certifications offered as students are applying for and obtaining legal employment.

#### Humanitarian Report— Karen Shearer

As you may recall, this year the MLSPA voted to assist Betty's Kids Backpack Blessings, an out-reach program for school kids who might otherwise not have meals. We selected this program in particular because of its connection with the legal community -- the program is administered by Attorney E. Colette Towles in Gulfport.

During the year, MSLPA donated \$75.00 cash from budgeted funds. Additionally members gave additional cash donations totaling \$30.00 as well as generously contributing food items. While our contribution may seem



the annual meeting in May. (As a reminder, the typical food which is sent home in back packs each week includes: Ravioli, Chicken Noodle Soup, Ramen Noodles, Vienna Sausage, saltine

crackers, tuna, mac and cheese, peanut butter and jelly, cereal bowls, individual packets of instant oatmeal and grits, Pop Tarts, breakfast bars, cookies, peanut butter crackers, chips, fruit juices and fruit snacks, and, when they can afford it, fresh fruit.) I learned from the Facebook page that some area grocery stores provide Ms. Towles significant discounts for this program, so monetary contributions go further than you might think!







