HAUNTED COURTHOUSES AND JAILS

Are you ready for cool weather (please) and colorful leaves? It's autumn, and pumpkin spice is in the air (and available in almost every type of food and drink). There's also the anticipation of All Hallows Eve—the one night of the year where the spirits of the dead can return to Earth. Except...for several courthouses and jails in Louisiana, Mississippi, and Texas, it's always October 31. Read their chilling tales of ghosts, unexplained whispers, and mysterious happenings. Then, this Halloween, try telling a (socially distanced) ghost story about one of these creepy courthouses:



LOUISIANA SUPREME COURT IN NEW ORLEANS, LOUISIANA

Several spectral residents haunt the Louisiana Supreme Court building. It's rumored that two witnesses were shot to death in a courtroom during a 1930s murder trial involving the Mafia. Some say the witnesses' footsteps echo throughout the courthouse halls at night. Legend also has it that a lawyer who lost a major case before the Supreme Court killed himself in the courthouse to save face. The ghost reportedly appears as a man in his 40s, wearing a

beige suit and carrying a briefcase. He walks the halls and stares out of the windows. Another ghost has been heard wailing or keening outside of the courthouse. No one knows why she cries.

BEAUREGARD PARISH JAIL IN DERIDDER, LOUISIANA

Beauregard Parish Jail is also known as the Hanging Jail and as the Gothic Jail. It was built in 1915 in a Gothic style with one foot thick concrete walls and a central spiral staircase. The gallows were at the top of the stairs. A trap



door would open on the top floor, and the body would drop and dangle between the floors. In 1928, two men convicted of



murdering a Deridder taxi driver were hanged at the same time. Residents believe the two still reside in the former jail. Paranormal investigators captured audio asking the ghosts: "Do you know that you're dead?" To which a spectral voice responds, "I'm alive. I'm alive."

Calcasieu Courthouse In Lake Charles, Louisiana



The Calcasieu courthouse staff knows exactly who haunts their building. She was the first and only woman executed in Louisiana's electric chair. Toni Jo Henry was a former prostitute who married a washed-up boxer and local criminal, Claude 'Cowboy' Henry. Shortly after they wed, Henry was convicted of murder and received a 50-year sentence. Intent on helping Henry escape prison, Toni Jo and a friend hijacked a car, shot the car's driver between the eyes, and dumped his body in a ditch. They both bragged about the

killing, but only Toni Jo was convicted of murder. Since her death, courthouse goers have

heard her screams, whispers, and footsteps. Visitors have also smelled her perfume. In different parts of the building, people are now saying they smell burning hair. Some think they may have a new ghost, but high levels of electrocution can burn hair.





DESOTO COUNTY COURTHOUSE IN HERNANDO, MISSISSIPPI



At this courthouse, two workers quit their jobs doing overnight mural restoration. They were so frightened they left and refused to return to finish the job. Courthouse staff hears slamming doors and disembodied voices around the clock. The courthouse burned down three times before its current incarnation, completed in 1941. Many of the court staff believe the man who burned it down the first time haunts the building. One staff member says she saw him sitting in a chair in front of her. He laughed and asked, "What are you doing sitting at my desk?" It's said there is an audiotape recording in the basement as proof of the haunting. "On the tape, you can hear doors slamming, chains rattling, and someone hollering out loudly for help. You can hear all kinds of strange noises. It definitely made me a believer," claims another staff member.

GRIMES COUNTY COURTHOUSE IN NAVASOTA, TEXAS

The current Grimes County Courthouse was preceded by four wooden and stone structures. All four were lost to fire or wind. The present courthouse has survived since 1894 and is still a working courthouse. But it has a feature that few other courthouses have: bullet holes dot the façade of the building. The holes are evidence of the five-day shootout between two



political parties over a highly disputed sheriff's election in 1900. The former sheriff and his deputies barricaded themselves in the jail, across the street from the courthouse, refusing to vacate

for the new sheriff. The new sheriff and his party barricaded themselves in the courthouse. In the five days of shooting, three men died and several others wounded.

The most mysterious thing about the courthouse is its elevator. It hasn't worked for decades, but people often hear the sounds of the gears grinding. One unfortunate employee heard the elevator grinding and went to make sure no one had tried to use it and gotten stuck. When the doors opened, he walked inside and saw no one was there—except for a blurry white ghost. As he tried to leave, the doors closed, trapping him in the elevator with the ghost. He was so frightened he fainted dead away. He wasn't found until an hour later by another employee. Some people thought he had a panic attack, but he is sure he saw a ghost. He quit working at the courthouse soon after this haunting incident.



October commemorates National Hispanic Heritage Month. Sonia Sotomayor was the first Hispanic federal judge in New York state, and she famously went on to become the first Hispanic Supreme Court Justice. Sotomayor, whose parents were Puerto Rican, grew up in New York City. Her father died when she was young, and she credits her mother with instilling in her a strong work ethic and a healthy stubborn streak. Sotomayor also credits a television show with inspiring her to pursue a career in law. Which popular television series inspired Sonia Sotomayor to become a lawyer?

Parliamentarian

I am working on conforming our bylaws and rules with the recent changes adopted by NALS, so this task is still pending. I had prepared a set of directions for a virtual meeting which was agreed up and used at the August meeting and assume these will continue to be the norm for Board meetings as long as we have virtual meetings. Until the bylaws and rules are completed, the manual revisions, if needed, are on hold. Please see the *Rules for Electronic Meetings* which was approved at the August meeting. Also, the proposed bylaw regarding virtual meetings follows. It will be included when it is time to vote on revised bylaws as a whole.

Rules for Electronic Meetings

- 1. <u>Login Information</u>. The Executive Secretary shall send by e-mail to every member of the Board, at least 24 hours before each meeting, the time of the meeting, the URL and codes necessary to connect to the Internet meeting service, and, as an alternative and backup to the audio connection included within the Internet service, the phone number and access code(s) the member needs to participate within aurally by telephone. The Executive Secretary shall also include a copy of, or a link to, these rules.
- 2. <u>Login time</u>. The Executive Secretary shall schedule Internet meeting service availability to begin at least 15 minutes before the start of each meeting.
- 3. <u>Signing in and out</u>. Members shall identify themselves as required to sign in to the Internet meeting service, and shall maintain Internet and audio access throughout the meeting whenever present, but shall sign out upon any departure before adjournment.
- 4. <u>Arrival announcements</u>. Members who participate in the meeting by phone/internet shall announce themselves at the first opportunity after joining the telephone conference call, by may not interrupt a speaker to do that. This is accomplished by using the raise hand command.
- 5. <u>Departure announcements</u>. Members who leave the telephone conference call or the meeting room before adjournment shall announce their departure, but may not interrupt a speaker to do so. This is accomplished by using the raise hand command.
- 6. **Quorum calls**. The presence of a quorum shall be established by audible roll call at the beginning of the meeting (or at agenda designation). Thereafter, the continued presence of a quorum shall be determined by the online list of participating members, unless any member demands a quorum count by audible roll call. Such a demand may be made following the departure of any member or following the taking of any vote for which the announced totals add to less than a quorum.
- 7. <u>Technical requirements and malfunctions</u>. Each member is responsible for his or her audio and Internet connections; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.
- 8. <u>Forced disconnections</u>. The President may cause or direct the disconnection or muting of a member's connection if it is causing undue interference with the meeting. The decision to do so, which is subject to an undebatable appeal that can be made by any member, shall be announced during the meeting and recorded in the minutes.
- 9. <u>Obtaining the floor</u>. To seek recognition by the President, a member shall use the raise hand command. When acknowledged by the President, a member shall address the President and state his or her name, similar to an in-person meeting obtaining the floor.
- 10. <u>Assignment of the floor</u>. To seek recognition by the President, a member shall use the raise hand command. The recognition of a member during a virtual meeting shall be followed as designated in the Rules of the Board Meeting, including the assignment of the floor, to make a motion, for a discussion, pending questions, etc. to the extent feasible and/or currently before the meeting for action or information, and if possible, displayed for review, all in accordance with actions prior to any voting and access to having the floor during virtual meetings. However, motions may be submitted in writing, displayed and/or can be oral. Interruptions, discussions and handling of same should be as if an in-person meeting.

- 11. **<u>Voting</u>**. Voting by the Board shall be oral and called for one by one by the President. Some virtual meetings have access to anonymous voting features of the Internet service and if this is necessary, shall be designated and conducted. Business may also be conducted by unanimous consent.
- 12. <u>Video Display</u>. If use of video of participants is too large to have all displayed simultaneously, the President or other designated officer shall be displayed throughout the meeting and shall also cause display of the video of the member currently recognized to speak or report.

PROPOSED BYLAW RE VIRTUAL MEETINGS:

ARTICLE V. MEMBER MEETINGS AND VOTING

ADD:

Section 6. Meetings Held Electronically.

Except as otherwise provided in these bylaws, meetings of the Board and Membership may be conducted through the use of Internet meeting services as designated and determined. These electronic meetings of the Board and Membership shall be subject to all rules adopted by the Board and Membership, to govern them, which may include any reasonable limitations on, and requirements for, Board or members' participation. Any such rules adopted by the Board and Membership shall supersede any conflict rules in the parliamentary authority but may not otherwise conflict with or alter any rule or decision of the Association.




Pine Belt Legal Professionals

Illustrious Information and Fun Facts about Mississippi

 Hernando de Soto, a Spanish explorer, discovered the Mississippi River on May 8, 1541.
 De Soto died of a fever in 1542. To avoid conflict with the local natives, he had encouraged them to believe he was an immortal Sun God.

Therefore, his men had to conceal his death. They hid his corpse in blankets, weighted it with sand, and sank it in the middle of the Mississippi River during the night.

- The name of the state is derived from the Mississippi River, 2,320 miles long, which flows along its western boundary. Settlers named it after the Ojibwe word misi-ziibi ('Great River.')
- Natchez was settled by the French in 1716. Prior to the Civil War, Natchez had the most millionaires of any city in the U.S. Today, the city boasts it has more antebellum (prior to the war) mansions than any other city.
- When shoes were first invented there were only shoes – not a left shoe, not a right shoe. In 1884, the concept of selling shoes in boxes in pairs (right and left foot) occurred in Vicksburg at Phil Gilbert's Shoe Parlor.
- On March 12, 1894, Joseph Augustus
 Biedenharn, the owner of a local wholesale candy
 company, bottled the first Coca-Cola in
 Vicksburg. Before that, Coca-Cola had only been
 available at soda fountains.

Biedenharn had been advised by his father to 'go into the nickel business,' meaning to offer soft drinks for 5 cents each. Prior to 1900, many folks would hold on to a dime but willingly spend a nickel for pleasure.

- Barq's Famous Olde Tyme Root Beer was created in Biloxi in 1898 by Edward Charles Edmond Barq. The brand is currently owned and operated by the Coca-Cola company.
- Children in the United States and Canada often count 'One-Mississippi, two-Mississippi' during informal games such as hide and seek to approximate counting by seconds.
